## 1.0 Purpose:

1.1 To keep Grandview Lake free of Zebra Mussels & other invasive species and monitor contractor boats.

## 2.0 Definitions:

- 2.1 **Boat:** Any motorized or non-motorized watercraft, including but not limited to ski boats, pontoons, personal watercraft (e.g., Jet Ski, SeaDoo), kayaks, canoes, paddle boats, sailboards, sailboat, stand up paddleboard, rowboats, ice boats, snowmobiles.

- 2.3 **Contractor:** A person or company performing a service for a customer at GLOA.

## 3.0 Permit and Cleaning Procedures

- 3.1 A contractor planning to bring a boat onto the lake is required to contact the office to set up a meeting to discuss the procedures for keeping their boat, trailer, and other gear free of invasive species.
  - 3.1.1 A list of inspection and cleaning procedures will be reviewed and provided to the contractor. This will include a list of waterways in Indiana known to contain Zebra Mussels.
  - 3.1.2 The Lake Manager or GLOA representative will provide a permit to be placed on the boat after a successful inspection.
  - 3.1.3 Contractor boats that do not have an active permit WILL NOT be allowed onto the lake.
- 3.2 Anytime a contractor's boat has been in waters outside of Grandview, the following will be required to re-enter Grandview Lake.
  - 3.2.1 Drain the bilge, live wells and engine cooling system and keep everything in the open drain position to allow for release of any water. Clean the boat, trailer and gear and allow time to dry.

- 3.2.2 Inspect the boat by checking the hull, trim plates, anchors, the trailer, and basically anything that contacts water.
- 3.2.3 Visible mussels or plants should be removed (via cleaning or scraping)
- 3.2.4 In early stages, mussels may not be as noticeable. Pass your hand over the bottom of the boat. If it feels GRAINY, you may have larval zebra mussels.
- 3.3 If you have been in any waters that have Zebra mussels (see attached DNR info sheet) or invasive plant species or any of these are found during the inspection process the following will be required before a permit is issued to access Grandview Lake.
  - 3.3.1 Wash down the boat with hot water (140°F).
  - 3.3.2 Disinfect all wells, engine, anchors, gear, and bait buckets with a 10% bleach solution, then flush again with water.
  - 3.3.3 Allow the boat and trailer to sit for 5-10 days to dry.
